- Upon the release by the Respondent Ernest Alexander Connell of all his mights over the area amounting to approximately 80 scres of land at present enclosed by fences upon the part of the common owned by the said Anthony Gary Peter Whitfield (such release to be effected by a separate Deed of Release mule between the said Ernest Alexander Connell and the sold Anthony Sory Peter "bitfield upon the terms agreed between them) the soid County Council shall not pursue its provisional registration of the said area as common land and the Rosgondents jointly and perecally consent to the umenament or withdrawal by the said County Council of its provisional registration pending before the Commons Commissioner of the said area so as to exclude all reference to the said area on the Commons Register and shall further consent to and our post any Aprilication by the said Anthony Cory Peter "hilfield or his successors in title to the Secretary of State regarding the said fences under Section 194 of the Law of Property Act 1925
 - by the said Anthony Gary Peter Whitfield amounting to approximately 100 seres of land shall be let by the said Anthony Cary Teter Whitfield to the said County Council for the term of 20 years from the date of the foregoing Order at the rent of \$200 per annum for



the first 5 years with appeards-only reviews at intervals of 5 10 and 15 years which letting shall provide inter alia for the management of the said land by the said County Council in such a way as to conserve its scientific and landscape qualities while permitting responsible access for the said Anthony Cary Feter Whitfield and his successors in title and for the public without prejudice to the confirmation of the registration of the said 100 acres as common land

5 Each of the parties shall bear their own costs occasioned by this Appeal without prejudice to the Order made by the Court below with respect to the costs of the proceedings in that Court
