PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT
MODIFICATION ORDER 2021

The above named Order, made on 11 August 2021 under Section 119 of the Highways Act 1980, will divert sections of the public footpaths. Part of Bramshott and Liphook Footpath 57 near Conford will be diverted just north of its current alignment, moving eastward along this route a small section will be diverted just south of its current alignment. Bramshott and Liphook Footpath 712 will be diverted from a point where footpath 57 merges, this will be diverted north to join Bramshott and Liphook Footpath 67 and continue west to rejoin Whitehill Footpath 12.

Please state the grounds on which they are made.

The personal data you provide in any representation will be treated in accordance with Data Protection Legislation, and may be published in a decision report, be disclosed to other interested parties, including the landowner (or their representatives). It may also be made public if the matter is referred to the Planning Inspectorate. Your data will be retained for a maximum period of two years from the date that the application is resolved. The legal basis for our use of this information is the compliance with a legal obligation – Highways Act 1980.

PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT
MODIFICATION ORDER 2021**

This Order is made by Hampshire County Council (“the authority”) under Section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 (“the 1981 Act”) because it appears to the authority that the Hampshire Definitive Map and Statement of Public Rights of Way (dated 15th December 2007) require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this order) of a highway shown or required to be shown in the map and statement.

The Ministry of Defence has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new path into a fit condition for use by the public.

East Hampshire District Council, South Downs National Park and Natural England have been consulted as required by Section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public right of way over the land situated in the parishes of Bramshott & Liphook and Whitehill, shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up when Hampshire County Council has certified that the work necessary to bring the site of the new footpath, specified in paragraph 3 below, into a fit condition for use by the public has been carried out, and thereupon the Hampshire Definitive Map of Public Rights of Way (dated 15th December 2007) shall be modified by deleting from it that public right of way.

2. Notwithstanding this Order all Statutory Undertakers shall have the same rights over the land referred to in paragraph 1 as they have hitherto enjoyed.
 3. There shall be from the date of confirmation of this Order a public footpath over the land situate in the parishes of Bramshott & Liphook and Whitehill described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this Order, and thereupon the Hampshire Definitive Map of Public Rights of Way (dated 15th December 2007) shall be modified by adding that footpath to it.
- 3A. The Hampshire Definitive Statement of Public Rights of Way (dated 15th December 2007) shall be modified as described in Part 4 of the Schedule to this Order.

DESCRIPTION OF SITE OF EXISTING RIGHTS OF WAY

Bramshott and Liphook No. 57
From SU 8219 3266 to 8206 3268

Footpath No. 57 in the Parish of Bramshott & Liphook, commencing at SU 8219 3266 (Point A on the order plan) proceeding westward to SU 8206 3268 (Point B on the order plan).

Approximately 137 metres in length.

Bramshott and Liphook No. 57
From SU 8161 3251 to 8155 3250

Footpath No. 57 in the Parish of Bramshott & Liphook, commencing at SU 8161 3251 (Point C on the order plan) proceeding westward to SU 8155 3250 (Point D on the order plan).

Approximately 65 metres in length.

Bramshott and Liphook No. 712
From SU 8121 3239 to 8085 3212

Footpath No. 712 in the Parish of Bramshott & Liphook, commencing at a junction with Bramshott and Liphook Footpath 57, SU 8121 3239 (Point E on the order plan) proceeding south-westward to the Parish Boundary, SU 8085 3212 (Point F on the order plan).

Approximately 455 metres in length.

Whitehill No. 12
From SU 8085 3212 to 8055 3182

Footpath No. 12 in the Parish of Whitehill, commencing at the Parish Boundary SU 8085 3212 (Point F on the order plan) proceeding south-westward to SU 8055 3182 (Point G on the order plan).

Approximately 445 metres in length.

DESCRIPTION OF SITE OF NEW RIGHT OF WAY

Bramshott and Liphook No. 57
From SU 8219 3266 to 8206 3268 via SU 8213 3271

A 2.5 metre wide path in the Parish of Bramshott & Liphook, commencing at SU 8219 3266 (Point A on the order plan), proceeding westward to the north of the existing definitive line via SU 8213 3271 to SU 8206 3268 (Point B on the order plan).

Approximately 152 metres in length.

Bramshott and Liphook No. 57
From SU 8161 3251 to 8155 3250 via SU 8158 3249

A 2.5 metre wide path in the Parish of Bramshott & Liphook, commencing at SU 8161 3251 (Point C on the order plan), proceeding south-westward to the south of the existing definitive line via SU 8158 3249, then north-westward to SU 8155 3250 (Point D on the order plan).

Approximately 78 metres in length.

Bramshott and Liphook Footpath No. 712a
From SU 8118 3254 to 8081 3226 via SU 8116 3253

A 2.5 metre wide path commencing at a junction with Bramshott and Liphook Footpath 67, SU 8118 3254 (Point H on the order plan), proceeding south-westward, via SU 8116 3253 (Point J on the order plan) to the Parish Boundary at SU 8081 3226 (Point K on the order plan).

Approximately 470 metres in length.

**Bramshott and Liphook Footpath No. 712b
From SU 8121 3239 to SU 8116 3253**

A 2.5 metre wide path commencing at a junction with Bramshott and Liphook Footpath 57, SU 8121 3239 (Point E on the order plan), proceeding north-westward to a junction with the new alignment of Bramshott and Liphook Footpath 712a, SU 8116 3253 (Point J on the order plan).

Approximately 148 metres in length.

**Whitehill No. 12
From SU 8081 3226 to 8055 3182**

A 2.5 metre wide path in the Parish of Whitehill, commencing at Parish Boundary, at a junction with Bramshott and Liphook Footpath 712a, SU 8081 3226 (Point K on the order plan) proceeding south-westward to SU 8055 3182 (Point G on the order plan).

Approximately 507 metres in length.

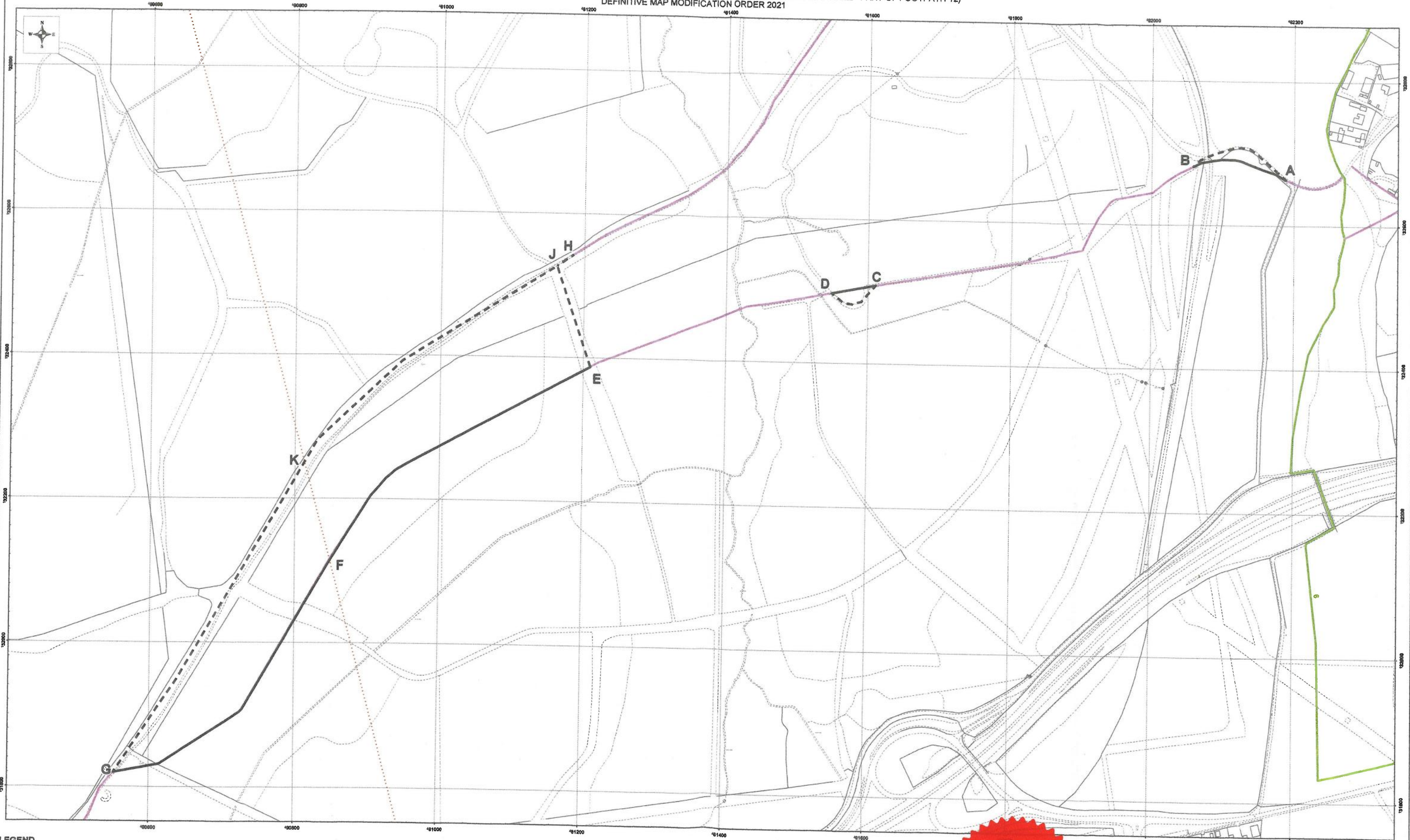
