#### THE HAMPSHIRE (EAST HAMPSHIRE DISTRICT NO.24) (PARISH OF SELBORNE – PART OF BRIDLEWAY NO.24 AND PARISH OF WORLDHAM – PART OF FOOTPATH NO.13) PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER 2021

The above named Order, made on 14 October 2021 under Section 119 of the Highways Act 1980, will divert a section of Selborne Bridleway 24 adjacent to Lower Wick Hill farm to an alignment just south of its current position, and Worldham Footpath 13 will be diverted from its current position to commence at a point on Wick Hill Farm Lane south of its current alignment and continuing in a north – easterly direction where the route crosses the current alignment and continues parallel to rejoin Worldham Footpath 13 on Wick Hill Hanger.

This Order is made by Hampshire County Council ("the authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in both the interests of the public and of owner of the land crossed by the public rights of way described in paragraph 1 of this order, it is expedient that the line of the path should be diverted.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Hampshire Definitive Map and Statement of Public Rights of Way (dated 15<sup>th</sup> December 2007) require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this order) of a highway shown or required to be shown in the map and statement.

Barry and Michael Boyson have agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new path into a fit condition for use by the public.

East Hampshire District Council has been consulted as required by Section 120(2) of the 1980 Act.

#### **BY THIS ORDER:**

1. The public rights of way over the land situated at Selborne and Worldham shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up when Hampshire County Council has certified that the work necessary to bring the site of the new footpath and bridleway, specified in paragraph 3 below, into a fit condition for use by the public has been carried out, and thereupon the Hampshire Definitive Map of Public Rights of Way (dated 15<sup>th</sup> December 2007) shall be modified by deleting from it those public rights of way.

## DESCRIPTION OF SITE OF EXISTING RIGHTS OF WAY

#### Selborne Bridleway No. 24 From SU 7487 3535 to SU 7505 3542

Bridleway No. 24 in the Parish of Selborne, commencing at SU 7487 3535 (Point A on the order plan) proceeding north-eastward along access track serving Lower Wick Hill Farm, to the Parish Boundary at SU 7505 3542 (Point B).

Approximately 188 metres in length.

#### Worldham Footpath No. 13 From SU 7512 3547 to SU 7545 3567

Footpath No. 13 in the Parish of Worldham, commencing at SU 7512 3547 (Point C on the order plan) proceeding north-eastward across arable field to woodland (Point D on the Order Plan), then north-westward to SU 7545 3567 (Point G).

Approximately 412 metres in length.

#### PART 2

#### DESCRIPTION OF SITE OF NEW RIGHT OF WAY

#### Selborne Bridleway No. 24 From SU 7487 3535 to SU 7504 3540

A 3.5 metre- wide path in the Parish of Selborne, commencing at SU 7487 3535 (Point A on the order plan) proceeding north-eastward along field edge to the Parish Boundary at SU 7504 3540 (Point E).

Approximately 179 metres in length.

#### Worldham Footpath No. 13 From SU 7507 3541 to SU 7545 3567 via SU 7512 3547

A 2 metre- wide path in the Parish of Worldham, commencing at a junction with Wick Hill Farm Lane SU 7507 3541 (Point F on the order plan) proceeding north-eastward along field boundary to SU 7512 3547 (Point C) then north-eastward across arable field to SU 7545 3567 (Point G).

Approximately 470 metres in length.


- 2. Notwithstanding this Order all Statutory Undertakers shall have the same rights over the land referred to in paragraph 1 as they have hitherto enjoyed.


