### **Background**

A hearing relating to the above application will take place at the offices of Hampshire County Council, The Castle, Winchester, SO23 8UL at 10am on Wednesday 17 May 2023. It will be conducted by J Burston BSc(Hons), MA, MRTPI and AIPROW, who is the Inspector appointed by the Secretary of State to determine the application.

### **Written statements**

In order to prepare for the hearing, it would assist the Inspector if those parties who have indicated they wish to participate could submit a written statement containing the details of their case. The statement should include copies of any supporting documents (including any legal authorities) that they intend to refer to at the Hearing. If any statement exceeds 1,500 words, it shall be accompanied by a summary of that statement.

All statements and further documents should be sent to the Planning Inspectorate by Wednesday 3 May 2023.

### **Procedure**

The Hearing will take the form of a structured discussion led by the Inspector based on an agreed agenda. The purpose of the Hearing is enable all parties to put forward your point of view and to help the Inspector get the information to make a decision.

There will be no formal presentation of cases or cross examination.

A provisional agenda is set out below showing the likely items and order of discussion.

The Inspector may convene a site visit following the close of the Hearing or, alternatively, adjourn the Hearing to the site so that discussions may continue there if required.

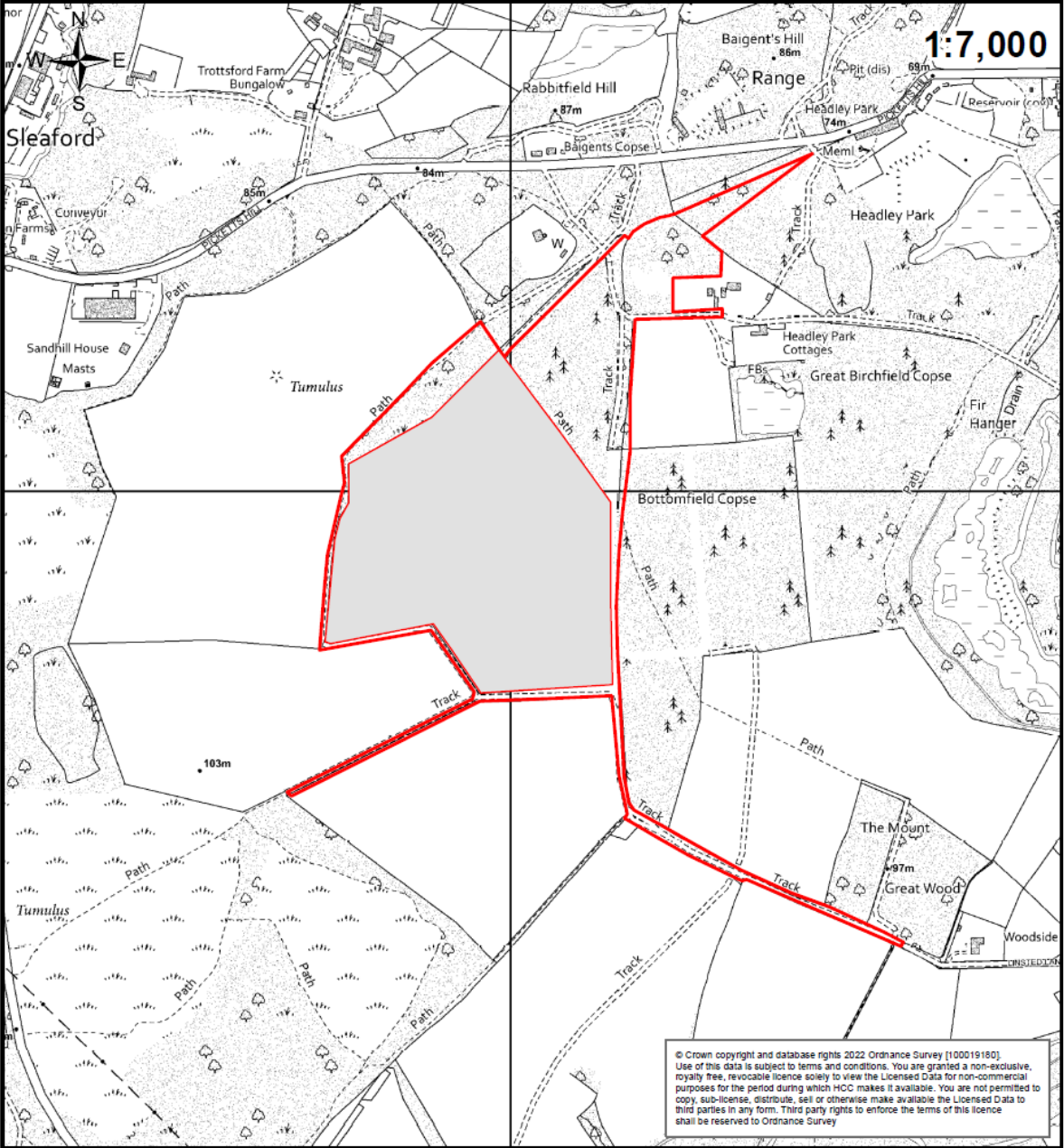
