THE HAMPSHIRE (EAST HAMPSHIRE DISTRICT NO. 27) (PARISH OF HEADLEY) DEFINITIVE MAP MODIFICATION ORDER 2008

This Order is made by Hampshire County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the Secretary of State for Environment Food and Rural Affairs that the Definitive Map and Statement of Public Rights of Way (Dated 15th December 2007) requires modification in consequence of the occurrence of an event specified in Section 53(3) (c) (i) of the Act namely:-

The discovery of evidence which (when considered with all other relevant evidence available) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way to which this Part applies.

The authority has consulted with every local authority whose area includes the land to which the Order relates.

Hampshire County Council hereby orders that:

- 1. For the purposes of the Order the relevant date is 18 September 2008.
- The Hampshire Definitive Map and Statement of Public Rights of Way (Dated 15th December 2007) shall be modified as described in Part I and Part II of the Schedule as shown on the maps attached to the Order.
- This Order shall take effect on the date it is it is confirmed and may be cited as The Hampshire (East Hampshire District No. 27)(Parish of Headley) Definitive Map Modification Order 2008.

Modification of Definitive Map Description of paths or ways to be added

From Grid Reference SU 8099 3818 to SU 8137 3844; and From Grid Reference SU 8096 3822 to SU 8111 3831

A 3.0 metre wide track running north-eastwards from Bridleway No. 54 to Picketts Hill between Points A, B and C on the accompanying map, with a 2.5 metre wide spur between points D and B.

A total length of 667 metres

From Grid Reference SU 8137 3845 to SU 8162 3874

A 2.5 metre wide track running north-eastwards from Picketts Hill to Byway Open to All Traffic No. 36, between Points E and F on the accompanying map.

A total length of 435 metres

Modification of Definitive Statement Variation of particulars of paths or ways

The following particulars shall become the Definitive Statement for the bridleways to be added to the Definitive Map by this order:

Bridleway between points A, B and C 3.0 metres wide

Bridleway between points D and B 2.5 metres wide

Bridleway between points E and F 2.5 metres wide
